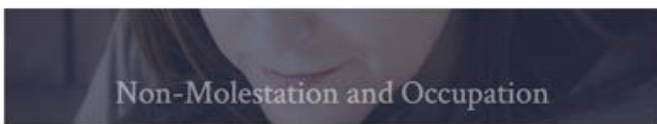
## Coming Soon
